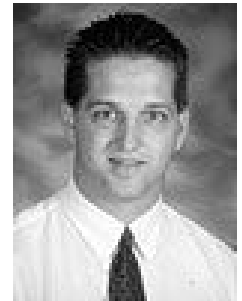
BEST PRACTICES CONFERENCE V:

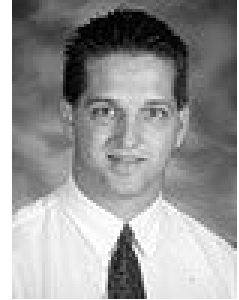
